



# Centennial Bank E-Statement Application

By signing below, I hereby request and agree to receive my Bank account statements, my related annual Privacy disclosure and any change-in-terms notices delivered to me electronically, at my E-mail address or to view my statements or disclosures via the Internet upon notice from the Bank that such information has been posted.

I understand and acknowledge that I presently have the right to receive such statements and disclosures in paper form, and that I may revoke this Authorization and Agreement at any time by providing the Bank with notice of such revocation by telephone or E-mail at the phone number or E-mail address shown below, at which time I will again be entitled to receive such statements and disclosures in paper form at no charge.

I understand and agree that even though I have agreed to receive statements electronically, I may contact the Bank by telephone or E-mail to request that the Bank send a paper copy of a statement that has already been sent or is available electronically, and that the Bank may charge a fee for that service, which will be separately disclosed. I agree that such fee can be deducted from any account that I own at the Bank.

I understand that I must complete a new Authorization and Agreement to Receive Electronic Statements form if my E-mail address changes. The effective date of this new E-mail address will be no more than 30 days from the day such notice is acknowledged as received by the Bank.

I understand that, in order to receive such disclosures electronically, I must have a PC with Internet access, maintain an E-mail address, have access to a printer or available storage space on my PC to retain a copy on file, and at a minimum, the following software and hardware:

- Adobe Acrobat Reader 5.1 or higher, (available free at [www.adobe.com/products/acrobat/readstep.html](http://www.adobe.com/products/acrobat/readstep.html)).
- Microsoft Windows XP, 2000, NT 4.0 with Service Pack 5 or 6 (Service Pack 6 recommended), Millennium Edition (Me) or 98 Second Edition,
- Microsoft Internet Explorer 5.0 or 6.0, Netscape 4.5-4.77 or 6.1 with the Internet Properties configured for Web access, or America Online 6.0,
- JavaScript must be enabled in the Web browser,
- PentiumR-class processor,
- 64 MB of RAM, and
- 30 MB of available hard disc space (an additional 60 MB is needed during installation).

I hereby acknowledge that my equipment meets those technical requirements for receiving, downloading, and printing the information.

I understand that in the event I experience difficulties or have questions regarding electronic statements or disclosures I can contact the Customer Service Department by telephone or E-mail.

I understand, that if in the future, the Bank upgrades its Internet delivery system, with the result that I may need upgraded hardware and/or software that differs from that referred to below, I may revoke this Authorization and Agreement in the same manner discussed earlier.

I understand that the Bank will issue a User Identification Number (ID) and Password to electronically access my statement and disclosures. I agree to change the Bank issued Password immediately, to keep the User ID secret, not to store it on my PC and to notify the Customer Services Department by telephone or E-mail if I believe that someone has learned the User ID or that it has been compromised in any way.

I understand and agree that the Bank retains the right, to the extent permitted by law, to amend this agreement in the future by providing me with written notice of such changes sent to my last known mailing address or by providing electronic notice of such changes sent to my last known E-mail address. In the future, should the Bank, by law or regulation, be permitted to deliver additional notices or disclosures to which I am entitled, I hereby agree to receive such notices or disclosures in electronic format sent to my last known E-mail address.

I understand that this agreement will not take effect until the Bank sends acknowledgement of the agreement via E-mail at the address listed below, and I consent by E-mailing notice of confirmation back to the Bank.

To receive or view statements, disclosures, notices electronically, complete the entire form below and sign it. You may drop off the form at any branch of the Bank. Please do not mail this form.

Once we have processed your request to receive electronic statements, we will send an acknowledgment E-mail to the address you indicate below. When you receive this message, **YOU WILL NEED TO SEND BACK A REPLY E-MAIL SO THAT WE MAY DETERMINE YOU HAVE THE MINIMUM EQUIPMENT NECESSARY TO RECEIVE STATEMENTS, DISCLOSURES AND NOTICES. IF YOU DO NOT REPLY WE WILL NOT SEND YOU ELECTRONIC STATEMENTS, DISCLOSURES OR NOTICES TO VIEW STATEMENTS.**

If your E-statement is returned to us undeliverable, a paper statement will be produced and sent to you via the U.S. Postal Service to the mailing address shown on our records the next business day. We will terminate the E-statement feature on your account if your E-statement is returned to us undeliverable for three consecutive months. All future statements will be delivered to you via the U.S. Postal Service to the mailing address shown on your records.
